Articulation Agreement between High School and North Shore Community College RENEWAL

202

Terms of Agreement

The purpose of this agreement is to establish and foster the linkages by which college credit and advanced standing may be awarded to students who successfully meet the articulation criteria. This agreement provides a method by which students can continue their education from one level to another without delay or duplication.

The terms of this agreement are the result of careful review and analysis of course materials, instructional methods, evaluation criteria and educational outcomes by the appropriate individuals, and departments of **High School** and **North Shore Community College**.

The college and **High School** faculty agree to continue collaboration on a seamless pathway from high school through college, to promote shared teaching strategies and effective evaluation and to participate in professional development activities to strengthen CVTE programs. Both institutions will offer programs and services that assist students who represent special populations.

Requirements for Articulated Credits

- Students must successfully complete a CVTE high school program.
- Students must meet North Shore Community College admissions requirements, as well as the requirements of the particular program for which they are applying.
- Students must be officially enrolled in a program of study at North Shore Community College.
- Students may apply for college credit within three years of their high school graduation.
- The Director of College Articulations and a Center for Alternative Studies designee are responsible for evaluating the high school transcript and approving the credit award.

Credit Award Process

- Once a student has applied and been accepted to North Shore Community College, s/he may submit an **Application for Evaluation of Credit Award** application to the College Articulation office, with a high school transcript.
- Documents are evaluated for eligibility by Director of Early College and Center for Alternative Studies designee.
- If all criteria for articulated credit are met, credit is processed through the Center for Alternative Studies and sent to Admissions to be applied to student's college transcript.
- Students will receive notification from Director of Early College the if the credit has either been awarded or denied along with an explanation.

This agreement shall be in effect and applicable to any graduate of **High School** commencing in **202X**. The agreement shall be reviewed periodically by the Superintendent or designee of **High School** and the Vice President for Academic Affairs or designee at North Shore Community College to assure that the provisions are still applicable. Changes may be made by mutual consent of the parties involved.

This agreement may be terminated by either party, in part or in its entirety, giving 90-day notice in writing to the other party. The provisions of the agreement shall remain in effect for students who are enrolled in the CVTE program prior to the 90-day notice. The provisions of this agreement shall also remain in effect for students who are matriculated and enrolled at North Shore Community College in a program of study for up to three years.

This articulation agreement is valid for two years from the contract date.

After such date has expired, a renewal contract will be required to keep the articulation agreement active. Articulation agreement credits may be redeemed for up to three years after a student's high school graduation date.
