**Category A**

I am a male U.S. citizen or eligible non-citizen, born after December 31, 1959, who is 18, but not yet 26 years of age.

You must register with Selective Service. To register online and for more information go to the Selective Service Web site at <http://www.sss.gov>. Provide us with a copy of your registration card or a copy of the online verification of your registration.

**Category B**

I am a male U.S. citizen or eligible non-citizen, born after December 31, 1959, who has never registered with Selective Service.

Students that were non-citizens who first entered the US after the age of 26 are not required to register.

If you are a male immigrant who first entered the United States past the registration age you may submit your official entry documentation that shows the first date of entry. If the document submitted is acceptable, you will not need to complete the following step. If the document submitted is not acceptable, you will need to follow the steps in Category C.

**Category C**

I am a male U.S. citizen or eligible non-citizen, born after December 31, 1959, who is 18, but not yet 26 years of age.

If Category B does not apply or you cannot provide the documentation you must **complete page two** of this form. You will also need to complete a **"Request Status Information Letter,"** which can be found on the Selective Service Website at [www.sss.gov](http://www.sss.gov) and mail it to Selective Service at the address provided. You will need to submit the Status Information Letter you receive back from them. The letter can take up to three to four weeks to receive.

**Category D**

I certify that I am not required to be registered with Selective Service because:

- I am a female.
- I am in the Armed Services on active duty. Attach a copy of active duty military I.D.
- I have not reached my 18th birthday.
- I was born before 1960.
- I am a resident of the Federated States of Micronesia or the Marshall Islands, or permanent resident of the Trust Territory of the Pacific Islands (Palau).
